When Itinerant is acting as placement agent, its service is to help the issuer raise capital in a private placement transaction.

Itinerant will represent one party (either the buyer or the seller) through an engagement letter, while the counterparty will be provided with information in order to make an informed decision. When we provide you with a recommendation, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money may create some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the recommendations we provide you. In return for its services as a placement agent, Itinerant will generally be paid a transaction-based fee.
