In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

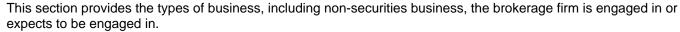

FIRM HAD A PROGRAM AT BARNETT BANKS IN FLORIDA WHERE THE FIRM WOULD MEET WITH AND OFFER ANNUITIES TO THE CUSTOMERS OF THE BANK. THE FLORIDA DOI ISSUED AN ORDER TO SHOW CAUSE, ALLEGING, AMONG OTHER THINGS, THAT THE FIRM AND ITS AFFILIATES WERE IN VIOLATION OF THE STATE'S ANTI-AFFILIATION STATUTES WHICH RESTRICTED THE SALE OF ANNUITIES AT A BANK. THE FIRM AND ITS AFFILIATES REQUESTED A HEARING WITH THE DEPARTMENT OF ADMINISTRATIVE HEARINGS. FIRM HAD A PROGRAM AT BARNETT BANKS IN FLORIDA WHERE THE FIRM WOULD MEET WITH AND OFFER ANNUITIES TO THE CUSTOMERS OF THE BANK. THE FLORIDA DOI ISSUED AN ORDER TO SHOW CAUSE, ALLEGING, AMONG OTHER THINGS. THAT THE FIRM AND ITS AFFILIATES WERE IN VIOLATION OF THE STATE'S ANTI-AFFILIATION STATUTES WHICH RESTRICTED THE SALE OF ANNUITIES AT A BANK. THE FIRM AND ITS AFFILIATES REQUESTED A HEARING WITH THE DEPARTMENT OF ADMINISTRATIVE HEARINGS. THIS RESULTED IN A FINAL ORDER FROM THE DOI FOR THE FIRM AND ITS AFFILIATES TO CEASE AND DESIST ANY ACTIVITIES WHICH VIOLATED THE FLORIDA ANTI-AFFILIATION STATUTES AND TO GET AN INSURANCE AGENCY LICENSE, ALTHOUGH AN AGENCY LICENSE FOR CORPORATIONS IS NOT TYPICALLY REQUIRED, WHILE ALL OTHER ALLEGATIONS WERE DROPPED. THE FIRM AND ITS AFFILIATES HAD ALREADY CONCLUDED ITS RELATIONSHIP WITH BARNETT BANKS AND THEREFORE DID NOT CHOOSE TO APPLY FOR AN INSURANCE AGENCY LICENSE AND WERE NOT AFFECTED BY THE CEASE AND DESIST ORDER. OTHER SANCTIONS AGAINST THE FIRM'S REGISTERED AFFILIATE ARE REPORTED ON HIS FORM U-4 DRP PAGE.
