FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional
 qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck
 reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
 same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.
- How current is this information?
- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Blas from a self-managed account at Fidelity. The sole reason for his move was to ensure that a professional advisor would actively manage his accounts during a

time

when he knew he would be unable to. [REDACTED] was scheduled to serve a sixmonth sentence beginning in November 2023 related to a guilty plea to federal

charges. During this time, he would have no access to his email and only the ability to

make outgoing phone calls. [REDACTED] told Ms. Peaslee multiple times that he expected her to make decisions regarding the accounts and investments while he was

away.

[REDACTED] claim is he has suffered substantial financial losses within these

accounts. When he

moved his account from Fidelity to San Blas in October 2023, the net account

value in

his primary account was \$1,506,828.34. As of July 31, it was \$228,416.99.
