BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

**Broker Statement**

MR. DUNNE STATED DURING A MEETING THE CUSTOMERS MADE HIM AWARE THEY WERE PAYING NO INCOME TAXES. ACCORDING TO MR. DUNNE, HE SUGGESTED PARTIAL WITHDRAWALS FROM THEIR ANNUITIES (SEVERAL ANNUITIES WERE HELD OUTSIDE OF EDWARD JONES) AND EXPLAINED THERE WOULD BE POTENTIAL TAXES TO PAY. HE FURTHER STATED HE INFORMED THE CUSTOMERS THERE WOULD BE TAXES DUE ON THE ANNUITIES AT SOME POINT. MR. DUNNE FURTHER EXPLAINED TO THE CUSTOMERS THAT HE IS NOT QUALIFIED TO GIVE FORMAL TAX ADVICE. THE REASON FOR THE PARTIAL WITHDRAWALS, ACCORDING TO MR. DUNNE, WAS TO DECREASE THE CUSTOMER'S EXPOSURE IN THE STOCK MARKET AND PAY SOME TAX NOW AT A LOWER RATE DUE TO THEIR AGES. OUR RECORDS INDICATE THE CUSTOMERS WITHDREW \$15,723.89 FROM THEIR AETNA GROWTH PLUS VARIABLE ANNUITY ON JULY 23, 2001, WITH THE PROCEEDS INVESTED INTO A PROVIDIAN NATIONAL BANK CD PAYING 5.35% MATURING AUGUST 15, 2006. IT APPEARS THE CUSTOMERS WERE PROVIDED WITH DETAILS OF THE PARTIAL WITHDRAWAL OF THEIR VARIABLE ANNUITY AND THE SUBSEQUENT CD PURCHASE. IT APPEARS THE PROCEEDS FROM THE PARTIAL AETNA WITHDRAWAL WAS NOT USED FOR A PURCHASE OF TAX FREE BONDS ACCORDING TO THE CLIENT ACCOUNT ACTIVITY. IT APPEARS MR. DUNNE ACTED PROPERLY IN THE HANDLING OF THE CUSTOMER'S ACCOUNT. THE CLIENT'S REQUEST FOR REIMBURSEMENT OF TAXES PAID BY THE CUSTOMERS AND THEIR ATTORNEY'S FEES ARE RESPECTFULLY DENIED.
