- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

I MET WITH CLIENT & WF PRIVATE BANKER ON 5/17/07 & ARRIVED WITH AN INCOME OBJ/MEDIUM RISK PROFILE & CLIENT AGREED WITH THE WFI OBJ/RISK PROFILE GUIDELINES. HE STATED HE WOULD BE INTERESTED IN INTL. INVESTMENTS/INTL. REAL ESTATE. CLIENT HAD A HISTORY OF REAL ESTATE INVESTING, OVERSEAS INVESTMENTS, & HAD A LARGE IRA AT ANOTHER FIRM IN STOCKS/BONDS. I RECOMMENDED TWO CLOSED END FUNDS INVESTING IN INTL. REAL ESTATE & STOCK/BONDS. I DELIVERED THE PROSPECTUSES TO CLIENT'S HOME & HE CALLED ME THE NEXT WEEK APPROVING THE TRADES. WE CHANGED THE PORTFOLIO OBJ. TO G & I OF WHICH THE CLIENT RECEIVED WRITTEN CONFIRMATION. SUBSEQUENT TO THESE TRADES, I CALLED CLIENT WITH 4 OTHER ADD'L INVESTMENT RECOMMENDATIONS, WHICH WERE APPROVED & PURCHASED BY CLIENT; 3 OF THESE INVESTMENTS WERE SOLD TO PURCHASE REAL ESTATE BY CLIENT. ON 11/29/07 HE PURCHASED \$150,000 OF EUROS & WIRED TO AN OVERSEAS BANK. IN 12/07, CLIENT SOLD CLOSED END FUNDS TO HELP OFFSET SOME REAL ESTATE GAINS ON HIS TAXES. AT THAT TIME, CLIENT APPROVED AN ADD'L INVESTMENT IN 2 GLOBAL FUNDS. CLIENT WITHDREW FUNDS ON A PERIODIC BASIS FROM HIS ACCOUNT & LIQUID RESERVES WERE MAINTAINED IN A MONEY MARKET FUND FOR THIS PURPOSE. IN APRIL/MAY 2008, CLIENT STATED HE NEEDED A LARGE AMOUNT OF CASH AROUND 6/1; I GAVE HIM TWO INVESTMENT SCENARIOS, ONE OF WHICH HE APPROVED. I ALSO CONTINUED TO REVIEW CLIENT'S PORTFOLIO WITH CLIENT & REVIEWED HIS OPTIONS FOR SOME OF THE INVESTMENTS WITH POORER PERFORMANCE. CLIENT NEVER ASKED TO SELL THEM OR INQUIRED ABOUT SELLING THEM. WE HELD SEVERAL CONFERENCE CALLS/FACE TO FACE MEETINGS REVIEWING HIS INVESTMENTS. NOT UNTIL OUR 9/16/08 CONFERENCE CALL, DID HE SAY THAT THE CLOSED END FUNDS MAY NOT BE APPROPRIATE FOR HIS ACCOUNT. I REVIEWED THE TIMELINE WITH HIM ON HOW HE WAS GIVEN AN OVERVIEW OF THE INVESTMENT & HE GAVE ME VERBAL APPROVAL FOR THE SPECIFIC INVESTMENTS EACH TIME. ALL OF HIS INVESTMENTS FIT HIS AGREED UPON INVESTMENT OBJ. & RISK PROFILE ACCORDING TO THE INVESTMENT GUIDELINES.
