- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. THE DEFENDANTS DECIDED TO SETTLE OUT OF COURT FOR THE NUISANCE VALUE OF LITIGATION. THE TOTAL SETTLEMENT WAS \$25,000. INTEGRATED RESOURCES PAID \$10,000; MARK RICHEY PAID \$6,000; [CUSTOMER] PAID \$6,000; RICHELLY FINANCIAL GROUP, INC. (THE CORPORATION) PAID \$3,000. A CRITICAL ELEMENT OF THE SETTLEMENT WAS THAT THE PARTIES AGREED THAT NONE OF THE DEFENDANTS ADMITTED ANY WRONG-DOING OR LIABILITY. IN MARCH OF 1989 WE RECEIVED, FROM A VERY REPUTABLE DENVER LAW FIRM ([THIRD PARTY]), A REQUEST, ON BEHALF OF THE PLAINTIFF, FOR AN EXPLANATION OF THE CLAIMS AGAINST US. WE COMPLIED IN WRITING WITH THEIR REQUEST; SUBSEQUENTLY, [THIRD PARTY] REFUSED TO HANDLE THE CASE. OUR ATTORNEYS ADVISED SETTLEMENT FOR THE "NUISANCE VALUE" AFTER THE PLAINTIFF FOUND OTHER COUNSEL. WE AGREED, ALTHOUGH WE INSIST THAT THE PLAINTIFF'S CLAIM WAS WITHOUT MERIT.
