BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

Allegations: CLIENT STATES THAT FROM 3/20/2000 TO 7/1/2002 HE WAS PUT IN CLASS B SHARES BUT WAS NEVER EXPLAINED WHICH SHARES WOULD PROVIDE HIM THE BEST DEAL FOR THE AMOUNT OF MONEY HE WAS INVESTING. HE ALSO STATES HE WAS PUT IN AN AGGRESSIVE FUND EVEN THOUGH IT WAS ONLY A SMALL PORTION OF HIS PORTFOLIO. THIS IS A COMPLAINT THE CLIENT FILED WITH THE NASD WHICH WAS FORWARDED TO THE FIRM. THE CLIENT ORIGINALLY FILED A COMPLAINT WITH THE FIRM IN AUGUST 2002. THE FIRM ADDRESSED THE MATTER AND DENIED THE COMPLAINT. AT THE TIME THE ORIGINAL COMPLAINT WAS FILED THE CLIENT DID NOT QUANTIFY THE AMOUNT IN DISPUTE OR PROVIDE A FIGURE FOR COMPENSATORY DAMAGES; ACCORDINGLY A U-4 AMENDMENT WAS NOT FILED AT THAT TIME. WITH THIS RECENT COMPLAINT MADE TO THE NASD THE CLIENT COMPLETED THE NASD COMPLAINT FORM ONLINE AND PROVIDED A FIGURE OF \$278,000 UNDER "AMOUNT IN DISPUTE". IT IS NOT CLEAR FROM THE NASD FORM IF THIS IS THE AMOUNT IN DISPUTE OR THE ALLEGED COMPENSATORY DAMAGE AMOUNT. THIS AMENDMENT IS BEING MADE BECAUSE THE AMOUNT PROVIDED IS GREATER THAN \$5,000.
