GEORGE J. CHARDUKIAN'S WISCONSIN INSURANCE LICENSE WAS REVOKED IN SEPTEMBER 1980, FOR FAILURE TO FILE COST DISCLOSURE FORMS. CHARDUKIAN WAS INVOLVED PART-TIME WITH AN INDEPENDENT AGENCY AT THAT TIME. SUBSEQUENT TO CHARDUKIAN'S EMPLOYMENT WITH PRUDENTIAL, HE CONTRACTED WITH AN INDEPENDENT BROKER, WHO REPRESENTED NUMEROUS INSURANCE CARRIERS, AND SIGNED A TEACHING CONTRACT WITH THE RACINE UNIFIED SCHOOL DISTRICT. HE RESIGNED HIS CONTRACT WITH PRUDENTIAL, AND PLACED HIS PERSONAL AND OTHER FAMILY MEMBERS' INSURANCE WITH OLD LINE LIFE, AND LEFT THE INSURANCE BUSINESS.
