- **What is included in a BrokerCheck report?**

BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

CUSTOMER DECIDED TO ACCEPT AND PAY FOR THE FULL AMOUNT. THE OPTIONS HEADED LOWER BY DAY'S END AND CUSTOMER BECAME IRRITATED. WITHIN A FEW DAYS HE INFERRED THAT HE NEVER PLACED AN ORDER FOR 1000 CONTRACTS AND WAS GOING TO ENTER ARBITRATION FOR A RECOVERY OF \$19,349.89, THE AMOUNT OF HIS LOSS WHEN THE OPTIONS WERE SOLD.
