BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

Broker Statement

[CUSTOMER] DISMISSED THE ACTION, WITH PREJUDICE, PURSUANT TO SETTLEMENT AGREEMENT DATED 3/26/93. [OTHER CUSTOMER NAMED], DISMISSED HER ACTION, WITH PREJUDICE, ON 2/09/93, PRIOR TO FINAL AGREEMENT. THE SETTLEMENT AGREEMENT INCLUDES NON-ADMISSION OF LIABILITY BY ANY OF THE PARTIES AND A CONSIDERATION OF \$40,000.00 PAYABLE BY TITAN VALUE EQUITIES GROUP, INC. (B/D) ONLY TO [CUSTOMER]. THE CUSTOMERS ALLEGE UNSUITABLE INVESTMENT RECOMMENDATIONS AS A RESULT OF LOSSES EXPERIENCED IN CONNECTION WITH FOUR INVESTMENTS. THE APPLICANT VEHEMANTLY DENIES ANY AND ALL ALLEGATIONS. THESE ALLEGATIONS ARE BASED ON FALSE INFORMATION, IGNORING EXISTING DOCUMENTATION DISPROVING THE ALLEGATIONS, AND MISREPRESENTATION OF CUSTOMER'S CONSIDERABLE INVESTMENT EXPERIENCE. ALTHOUGH BOTH OF THE PLAINTIFFS SIGNED ARBITRATION AGREEMENTS AT TIME OF INVESTMENT (1986 AND 1987), THEY INSISTED ON A COURT TRIAL AND APPEALED TO THE COURT FOR SUCH A TRIAL. DUE TO THE SIGNIFICANT ATTORNEY AND COURT COSTS OF A TRIAL. THE BROKER/DEALER, TITAN, AGREED TO A DISMISSAL OF THE ACTION WITH REMUNERATION AND WITH NON-ADMISSION OF LIABILITY BY ANY PARTIES.
