- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

**Allegations:** Without admitting or denying the findings, Mathews consented to the sanctions and to the entry of findings that he engaged in an unsuitable pattern of short-term trading of Unit Investment Trusts (UITs) in customer accounts. The findings stated that Mathews recommended that his customers roll over UITs more than 100 days prior to their maturity on approximately 1,800 occasions. Indeed, although his customers' UITs typically had a 15- or 24-month maturity period, Mathews recommended that they sell their UITs after holding them for, on average, only 262 days and use the proceeds to purchase a new UIT. Of the approximately 1,800 early rollovers recommended by Mathews, approximately 330 were series-to-series rollovers. In other words, on approximately 330 occasions, Mathews recommended that his customers roll over a UIT before its maturity date in order to



purchase a subsequent series of the same UIT, which, as noted above, generally had the same or similar investment objectives and strategies as the prior series. Mathews' recommendations caused his customers to incur unnecessary sales charges and were unsuitable in view of the frequency and cost of the transactions.
