BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. ELIZABETH C. TAIMI WAS DISCHARGED FOR CAUSE FROM HER EMPLOYMENT AT MEYER INC. WHILE WORKING IN THE CAPACITY OF A FULL-TIME CASHIER, TAIMI WAS ASSIGNED TO OTHER JOB DUTIES, SUCH AS AN ASSISTANT BOOKKEEPER. WHILE IN THE BOOKKEEPER'S CAPACITY, TAIMI DISCOVERED AN IRREGULAR HAPPENING AND WENT TO THE STORE DIRECTOR WITH HER FINDINGS. TAIMI DISCLOSED THAT THE BOOKKEEPERS WERE FORCING BALANCES ON THE BOOKS AT THE STORE LEVEL. TAIMI WAS VERBALLY REPRIMANDED AND WAS TOLD THAT SHE WAS TREATING HER MANAGERS LIKE SCUM AND THAT IT WAS NOT HER BUSINESS. THEREFORE, TAIMI PROCEEDED TO PROVE HER ALLEGATIONS BY DOING EXACTLY WHAT SHE TOLD THEM WAS BEING DONE. TAIMI TOOK MONIES OVER A PERIOD OF TIME (4 MONTHS) BUT, NEVER SPENDING IT. SHE KEPT IT IN AN ENVELOPE AND RETURNED IT TO THE COMPANY IN THE EXACT BILLS TAKEN



(\$7,000) ALL \$100 BILLS. BEFORE TAIMI HAD THE CHANCE TO COMPLETE HER PLAN, THE COMPANY DISCOVERED AFTER 4 MONTHS THAT THEY WERE IN FACT LOSING MONEY. TAIMI WAS FINALLY CONFRONTED AND SHE GAVE THE COMPANY THE \$7,000.00 AND A WRITTEN STATEMENT. THE COMPANY FILED A COMPLAINT WITH THE STATE POLICE. TAIMI STATED THAT THE PROSECUTING ATTORNEY REFUSED THE CASE.
