BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional
 qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck
 reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
 same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.
- How current is this information?
- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.
- What if I want to check the background of an investment adviser firm or investment adviser representative?
- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. If your search is successful, click on the link provided to view the available licensing and registration information in the SEC's Investment Adviser Public Disclosure (IAPD) website at https://www.adviserinfo.sec.gov. In the alternative, you may search the IAPD website directly or contact your state securities regulator at http://www.finra.org/Investors/ToolsCalculators/BrokerCheck/P455414.
- Are there other resources I can use to check the background of investment professionals?
- FINRA recommends that you learn as much as possible about an investment professional before deciding
 to work with them. Your state securities regulator can help you research brokers and investment adviser
 representatives doing business in your state.

Disclosure Events



What you should know about reported disclosure events:

1. All individuals registered to sell securities or provide investment advice are required to disclose customer complaints and arbitrations, regulatory actions, employment terminations, bankruptcy filings, and criminal or civil judicial proceedings.

2. Certain thresholds must be met before an event is reported to CRD, for example:

- o A law enforcement agency must file formal charges before a broker is required to disclose a particular criminal event.
- A customer dispute must involve allegations that a broker engaged in activity that violates certain rules or conduct governing the industry and that the activity resulted in damages of at least \$5,000.

3. Disclosure events in BrokerCheck reports come from different sources:

- o A final event generally has a disposition of adjudicated, settled or otherwise resolved.
 - An "adjudicated" matter includes a disposition by (1) a court of law in a criminal or civil matter, or (2) an administrative panel in an action brought by a regulator that is contested by the party charged with some alleged wrongdoing.
 - A "settled" matter generally involves an agreement by the parties to resolve the matter. Please note that brokers and brokerage firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually involves no payment to the customer and no finding of wrongdoing on the part of the individual broker. Such matters generally involve customer disputes.

THE INDIVIDUAL THAT WOULD ULTIMATELY BE MY SUPERVISOR AT SUNTRUST.IN THOSE DISCUSSIONS AND CONVERSATIONS WITH MY SUPERVISOR, I COMPLETELY AND THOROUGHLY DISCLOSED ALL OF MY BUSINESS ACTIVITIES AND ALL OF MY CONSIDERATIONS AND DECISION

POINTS RELATIVE TO MY EMPLOYMENT WITH SUNTRUST.

THE SUPERVISOR IN QUESTION CLEARLY INDICATED THAT THERE WAS NO NEED TO DISCLOSE ANY OF THE BUSINESS ACTIVITIES WE DISCUSSED ON MY U4. FURTHERMORE, SUNTRUST WOULD MAKE ARRANGEMENTS TO ASSIMILATE THESE BUSINESS ACTIVITIES INTO THEIR BUSINESS MODEL. I HAVE DOCUMENTATION RELATING TO THESE DISCUSSIONS DESCRIBED ABOVE AND SUNTRUST'S DIRECTION RELATIVE TO THESE SUBJECTS. SOMETIME AFTER THE SUPERVISOR THAT HIRED ME WAS DISCHARGED, MY NEW SUPERVISOR AT SUNTRUST INFORMED ME THAT SUNTRUST WAS NOT GOING TO ACCOMMODATE THE ACTIVITIES IN QUESTION. I WOULD EITHER HAVE TO RELINQUISH THE ACTIVITIES, RESIGN, OR THEY WOULD TERMINATE ME FOR MY FAILURE TO DO



SO.GIVEN THAT I HAD FULLY DISCLOSED THE ACTIVITIES TO SUNTRUST AND THEY AGREED TO ACCOMMODATE THE ACTIVITIES, I DID NOT FEEL, THEREFORE, THAT IT WAS FAIR TO ME TO HAVE TO GIVE UP THESE ACTIVITIES OR FOR SUNTRUST TO ASK ME TO RESIGN. AGAIN, THESE ACTIVITIES WERE FULLY DISCLOSED PRIOR TO MY EMPLOYMENT AND MY DECISION TO JOIN SUNTRUST WAS PREDICATED ON SUNTRUST'S AGREEMENT AND ACCEPTANCE OF THESE ACTIVITIES INTO THEIR BUSINESS MODEL. SUNTRUST'S ULTIMATE DECISION TO TERMINATE ME STEMMED FROM MY UNWILLINGNESS TO ACCEPT EITHER OF THE OTHER TWO OPTIONS.
