BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional
 qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck
 reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
 same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.
- How current is this information?
- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- Are there other resources I can use to check the background of investment professionals?

RUMMELLS CAUSED HIS AUNT, A CUSTOMER OF HIS MEMBER FIRM, TO LOAN A TOTAL OF \$625,234 ON SIX SEPARATE OCCASIONS TO A HOLDING COMPANY, WHICH HAD FINANCIAL DIFFICULTIES AND IN WHICH RUMMELLS

WAS A ONE-THIRD OWNER. THE FIRM DID NOT PERMIT BORROWING FROM CUSTOMERS, EXCEPT UNDER LIMITED CIRCUMSTANCES, AND ONLY WITH PRIOR FIRM APPROVAL. RUMMELLS DID NOT REQUEST APPROVAL FORM HIS FIRM TO BORROW MONEY FROM HIS AUNT IN THE MANNER REQUIRED UNDER THE FIRM'S PROCEDURES. RUMMELLS HAS FULLY

CAUSED HIS AUNT, A CUSTOMER AT EDWARD JONES, TO LOAN A TOTAL

OF \$625, 234 TO A HOLDING COMPANY WHICH HE WAS ONE-THIRD OWNER. EDWARD JONES DID NOT PERMIT BORROWING FROM

CUSTOMERS EXCEPT UNDER LIMITED CIRCUMSTANCES AND ONLY WITH FIRM APPROVAL. ACCORDING TO EDWARD JONES, MR. RUMMELLS DID NOT REQUEST APPROVAL FROM EDWARD JONES TO BORROW MONEY FROM HIS AUNT AS REQUIRED BY THE FIRMS PROCEDURES AND NASD RULE 2370 AND FINRA RULES 3240 AND 2010. RUMMELLS HAS FULLY

REPAID THE LOANS TO THE CUSTOMER.
