BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement

MS. HOULIHAN VEHEMENTLY DENIES ANY ALLEGATIONS OF WRONGDOING IN CONNECTION WITH THIS MATTER AND WAS NOT REQUIRED TO CONTRIBUTE IN ANY WAY TO THE SETTLEMENT BETWEEN THE PARTIES. MS. HOULIHAN FURTHER STATES THAT SHE WAS WAS NOT THE FINANCIAL ADVISOR ON THE ACCOUNTS AT ISSUE, BUT RATHER SERVED ONLY AS A SALES ASSISTANT TO THE CLIENT. CLAIMANT, WHO ALLEGED THAT SHE AND HER FAMILY SHOULD HAVE BEEN INSTRUCTED TO DIVERSIFY THEIR LEHMAN BROTHERS' STOCK HOLDINGS PRIOR TO THE FIRM'S BANKRUPTCY IN THE FALL OF 2008, WAS HERSELF A FORMER SENIOR VICE PRESIDENT AT LEHMAN BROTHERS AND WAS ADVISED ON A NUMBER OF OCCASIONS WELL-PRIOR TO LEHMAN BROTHERS' BANKRUPTCY TO DIVERSIFY HER LEHMAN BROTHERS' HOLDINGS (THE OTHER CLAIMANTS' WERE SIMILALRY INSTRUCTED). THE SETTLEMENT IN THIS MATTER WAS STRICTLY A BUSINESS DECISION THAT WAS MADE AMONGST THE PARTIES. MS. HOULIHAN WAS NOT REQUIRED TO CONTRIBUTE IN ANY WAY TO IT.
