- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement	THIS CUSTOMER COMPLAINT IS NO LONGER REPORTABLE. THE ALLEGATIONS MADE BY THE COMPLAINANT ARE BOTH FALSE & UNWARRANTED. THE COMPLAINANT CAME TO MY OFFICE

UNANNOUNCED, OF HIS OWN ACCORD, WITHOUT ANY PROMPTING FROM ME ON 10/4/00. HE HAD HIS AARP/SCUDDER, PIPER JAFFRAY & VANKAMPEN STATEMENTS WITH HIM. DURING OUR MEETING, HE REPEATEDLY SAID "I DO NOT WANT ANY MORE MARKET FLUCTUATIONS WITH MY INVESTMENTS. I'M TOO OLD & HAVE TOO MANY OTHER PROBLEMS TO DEAL WITH. WHAT CAN YOU DO TO HELP ME?" I TOLD HIM THAT THERE WERE 2 PRODUCTS THAT WOULD FIT HIS CRITERIA OF "NO MARKET FLUCTUATIONS"-OUR MONEY MARKET & FEDERALLY INSURED CERTIFICATES OF DEPOSIT (CDS). I WENT ON TO EXPLAIN THAT ALTHOUGH THE CDS WOULD ALWAYS SHOW AS FULL PRINCIPAL VALUE ON HIS STATEMENTS THAT HE COULD VERY WELL EXPERIENCE A MARKET IMPOSED PENALTY SHOULD HE LIQUIDATE THEM PRIOR TO MATURITY. HE THEN SAID THAT HE WANTED TO DO THE CDS & ASKED ME WHAT HE NEEDED TO ACCOMPLISH THAT. I EXPLAINED THAT WE COULD LIQUIDATE HIS PIPER JAFFRAY HOLDINGS THAT DAY OVER OUR COMPUTER SYSTEM BUT THAT HE WOULD NEED TO CONTACT AARP/SCUDDER & VANKAMPEN TO LIQUIDATE THOSE HOLDINGS. HE SHOULD HAVE THEM EITHER SEND THE PROCEEDS TO HIM OR DIRECTLY TO HIS PIPER JAFFRAY ACCOUNT. HE THEN ASKED IF THERE WAS ANYWAY WE COULD DO THAT FOR HIM. I EXPLAINED THAT WE COULD COMPLETE MUTUAL FUND REDEMPTION FORMS, TAKE A COPY OF HIS STATEMENTS & MAIL THEM DIRECTLY TO THE FUNDS. I ALSO EXPLAINED THAT IF WE DID IT THAT WAY THE PROCESS WOULD TAKE ADDITIONAL TIME COMPARED TO HIS CALLING THE FUNDS DIRECTLY. HE THEN STATED HE DIDN'T WANT TO DEAL WITH THE LIQUIDATIONS HIMSELF. HE WANTED US TO DO THEM FOR HIM. I MADE COPIES OF HIS STATEMENTS, COMPLETED & HAD HIM SIGN THE MUTUAL FUND REDEMPTION FROMS & GOT THEM IN THAT DAY'S MAIL. DURING 9 SUBSEQUENT CONTACTS WITH HIM, HE NEVER ONCE ASKED, "WHY DID YOU LIQUIDATE MY HOLDINGS?" THAT IS BECAUSE HE HAD REQUESTED ME TO DO SO.
