BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

EXECUTOR CLAIMS THAT THE PUTNAM INVESTMENTS WERE NOT SUITABLE FOR THE CLIENT, AND IS ALSO UPSET WITH THE FEE CHARGED TO CLOSE THE ACCOUNT. EXECUTOR STATES CLIENT LOST OVER \$28,000 AT EDWARD JONES DUE TO THE PERFORMANCE OF VARIOUS PUTNAM FUNDS IN WHICH THE IR INVESTED THE CLIENT'S MONEY.

SEVERAL FUNDS WERE BOUGHT IN THE ACCOUNT FROM 1991-2000. IR STATED HE DISCUSSED IN DETAIL EACH INDIVIDUAL INVESTMENT, COMMISSIONS, AND THE RISKS ASSOCIATED WITH INVESTING. IR INDICATED THAT CLIENT'S ACCOUNT WAS REVIEWED WITH THE CLIENT ON AN ANNUAL BASIS AND CLIENT WAS KEPT APPRISED OF HER INVESTMENTS AND UNDERSTOOD THE RISKS ASSOCIATED WITH INVESTING. IN ADDITION, IT APPEARS THE CLIENT WAS TAKING MONTHLY INCOME FROM THE ACCOUNT. IT IS OUR OPINION ALL TRANSACTIONS EFFECTED IN THE ACCOUNT WERE AUTHORIZED. IN ADDITION, IT DOES NOT APPEAR THE INVESTMENTS PURCHASED AND/OR HELD IN THE ACCOUNT WERE OUTSIDE THE SCOPE OF THE INVESTMENT OBJECTIVES OF THE ACCOUNT, AND THAT THE LOSSES IN THE ACCOUNT WERE DUE TO MARKET FLUCTUATION AND WITHDRAWALS. A FEE OF \$299.39 WAS CHARGED TO THE ESTATE ACCOUNT. THE FEE IS WITHIN THE FIRM'S GUIDELINES. SO LONG AS THE IR HAS SPENT A SIGNIFICANT TIME PROVIDING APPROVED SERVICES WHERE NO COMPENSATION HAS BEEN DIRECTLY OR INDIRECTLY RECEIVED, THE IR MAY CHARGE A REASONABLE FEE FOR SERVICES PROVIDED. THIS FEE MUST ALSO GO THROUGH A SUPERVISORY APPROVAL PROCESS BEFORE THE FEE IS APPROVED.
