BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

THE IR HAS INDICATED, AT THE TIME OF THE TRANSFER, THE CLIENT EXPRESSED DISAPPOINTMENT WITH THE PERFORMANCE OF THE VAN KAMPEN FUNDS. THE IR HAS INDICATED HE EXPLAINED THE HISTORICAL PERFORMANCE OF THE FUNDS WAS VERY POSITIVE. THE IR HAS STATED DURING HIS MEETING WITH THE CLIENT ON MARCH 12, 2002, THE CLIENT EXPRESSED HIS INTENT ON CONTINUING TO TAKE DISTRIBUTIONS AT THE SAME RATE. THE IR HAS FURTHER INDICATED HE ADVISED TO THE CLIENT, DUE TO THE DECLINE IN THE VALUE OF THE ACCOUNT, THE CLIENT WAS NOW REMOVING APPROXIMATELY 15% OF THE ACCOUNT VALUE PER YEAR AND THAT HE WOULD NEED TO ACHIEVE AN EQUAL RATE OF RETURN IN ORDER TO MAINTAIN THE ACCOUNT VALUE. IT APPEARS THE IR HAD MULTIPLE CONVERSATIONS WITH THE CLIENT DURING THE NEXT SEVERAL MONTHS RELATED TO THE OPTIONS AVAILABLE TO HIM INCLUDING THE POTENTIAL TO MAKE A ONE-TIME CHANGE TO THE AMOUNT OF THE 72T DISTRIBUTION. AT THE TIME OF THE PURCHASES IN THE ACCOUNT (IN 2000), THE CLIENT RECEIVED TRADE CONFIRMATIONS WHICH PROVIDED DETAILS OF THE TRANSACTIONS. IN ADDITION, THE CLIENT HAS RECEIVED STATEMENTS THAT PROVIDE INFORMATION REGARDING THE INVESTMENTS HELD IN THE ACCOUNT AS WELL AS REFLECTING ACCOUNT ACTIVITY. THE INVESTMENTS PURCHASED IN THE ACCOUNT DO NOT APPEAR TO BE OUTSIDE THE SCOPE OF THE INVESTMENT OBJECTIVES OF THE ACCOUNT. BASED ON OUR REVIEW, ALL TRANSACTIONS EFFECTED IN THE ACCOUNT WERE COMPLETED WITH CLIENT'S KNOWLEDGE AND AUTHORIZATION. WHILE WE UNDERSTAND THE CLIENT'S DISAPPOINTMENT REGARDING THE DECLINE IN THE VALUE OF THE ACCOUNT, THE DECLINE IS ATTRIBUTED TO WITHDRAWALS AS WELL AS MARKET FLUCTUATION. CLAIM DENIED.
