- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. MICHAEL J. ALLAN
RETURNED AN ITEM TO A STORE WITHOUT A RECEIPT AND WAS TOLD BY THE CLERK THAT A CHECK WOULD BE MAILED TO HIM WITHIN TWO WEEKS, SINCE HE DID NOT HAVE A RECEIPT. HE DID GET A RECEIPT FOR THE REFUND DUE. TWO WEEKS LATER HE STOPPED BY THE STORE TO FIND OUT ABOUT THE REFUND. THE HEAD OF SECURITY INFORMED HIM THAT HE WOULD HAVE TO PRODUCE A RECEIPT TO GET THE REFUND, AND REFUSED TO RETURN THE ITEM TO HIM. FROM THE STORE, ALLAN CALLED THE DISTRICT ATTORNEY'S OFFICE TO FILE CHARGES AGAINST THE STORE AND
WAS INFORMED THAT THIS WAS A CIVIL, NOT A CRIMINAL ISSUE. A HEATED CONVERSATION WITH THE HEAD OF SECURITY ENSUED IN WHICH ALLAN ASKED FOR EITHER THE CHECK OR THE ITEM, WHICH HE REFUSED. ALLAN PICKED UP MERCHANDISE AND WALKED OUT OF THE STORE. THE POLICE WERE CALLED AND ALLAN WAS TOLD TO SELF-SURRENDER THE NEXT MORNING. AFTER CONSULTING A LAWYER, ALLAN WAS ADVISED TO PLEAD GUILTY TO SHOPLIFTING (A MISDEMEANOR) . THE



STORE FILED FOR CHAPTER 11, AND ALLAN DROPPED CIVIL PURSUIT FOR
RESTITUTION.
