FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

 - A "resolved" matter usually involves no payment to the customer and no finding of wrongdoing on the part of the individual broker. Such matters generally involve customer disputes.

(FIRST INVESTMENTS) THE FIRM PAID HIM \$15,033.50, NO ACTION WAS TAKEN AGAINST ME. ON 3/26/1997 I RECEIVED A LETTER FROM THE NASD STATING THEY HAD COMPLETED THEIR INVESTIGATION OF THESE CIRCUMSTANCES. THEY DETERMINED THAT NO ACTION AGAINST ME WAS WARRENTED, AND THEREFORE THE MATTER IS BEING CLOSED.

THE FIRM (FIRSTAR INVESTMENT SERVICE IS A DIVISION OF ELAN INVESTMENT SERVICES PAID HIM \$15,033.50 (HE IS A BIG BANK CUSTOMER) CONTRARY TO WHAT I WAS TOLD BEFORE I LEFT THE FIRM ON 3/22/96. AS OF 3/20/96 MY FORMER MANAGER (CHARLES RICE) TOLD ME THEY WERE OFFERING NOTHING. THE CLIENT ASKED ME TO PROVIDED SOME CLOSED END FUNDS TRADING AT A DISCOUNT TO NAV.

THAT INFORMATION WAS FOUND IN THE S&P STOCK GUIDE. APPARENTLY THE FUND WAS SUPPORTING THE DIVIDEND OUT OF A RESERVE. MY FIRM PROVIDED NO INFORMATION. I WAS ABLE TO DETERMINE THE PORTFOLIO.

BUT, I DID NOT KNOW ABOUT THE DIVIDEND RESERVE. THE ORDERS WERE UNSOLICITED. HE CLAIMS I SHOULD HAVE TOLD HIM, BUT I CAN'T TELL



HIM WHAT I DON'T KNOW. THE GUY IS A SOPHISTICATED INVESTOR, BUYS ON MARGIN HAS OVER \$1,000,000 IN INVESTMENTS AND BUYS OPTIONS HIGH YIELD FUNDS AND JUNK BONDS. ON 3/20/96 MY MANAGER TOLD ME THEY WERE NOT GOING TO GIVE HIM AND MONEY. AFTER I LEFT THEY APPARENTLY CHANGED THEIR MINDS. FIRSTAR INVESTMENT SERVICES, A DIVISION OF ELAN INVESTMENT SERVICES. I RECEIVED A LETTER DATED MARCH 26, 1997 FROM THE NATIONAL ASSOCIATION OF SECURITIES DEALERS INDICATING THAT THEY HAD COMPLETED THEIR INVESTIGATION OF THESE CIRCUMSTANCES. THEY DETERMINED THAT NO ACTION AGAINST ME IS WARRANTED, AND THEREFORE, THE MATTER IS BEING CLOSED.
