About BrokerCheck®

BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: Without admitting or denying the findings, Tauzin consented to the sanctions and to the entry of findings that he engaged in a pattern of unsuitable short-term trading of front-loaded Unit Investment Trusts (UITs) in connection with the accounts of households that were customers of his member firm. Tauzin had no reasonable basis to believe the short-term trading of these front-loaded products was suitable for the customers. The findings stated that Tauzin also maintained blank forms signed by customers relating to accounts for several households. The forms included Automated Clearing House (ACH) authorization forms, margin agreements, account applications and switch disclosure forms. With regards to certain households, completed switch disclosure forms were used for transactions that appeared identical to the signed, blank forms maintained in Tauzin's files. The



maintenance of the blank forms violated the firm's written supervisory procedures, which prohibited registered representatives from having customers sign any blank document, regardless of client knowledge or consent.
