BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

THE CLIENT ALSO QUESTIONED THE SUITABILITY OF THE INVESTMENTS MADE WITHIN THE ANNUITIES FOR A PERSON 72 YEARS OLD. IN ADDITION, SHE CLAIMED THAT SHE DID NOT SIGN OR RETURN THE DELIVERY FORMS.

MR. CURRAN ADVISED THAT HE NEVER "GUARANTEED" ANY RETURNS FOR THESE ANNUITIES. ALL OF THE FEATURES OF THE ANNUITIES WERE PROPERLY DISCLOSED AT THE TIME OF PURCHASE. CURREN STRESSED THE MARKET RISKS AND FLUCTUATION ASSOCIATED WITH THE STOCK AND BOND FUNDS HELD IN THE ANNUITIES. THE CLIENT ALSO RECEIVED THE PROSPECTUSES , WHICH FURTHER DISCLOSED THE RISKS ASSOCIATED WITH THESE INVESTMENTS. ONE OF THE ANNUITIES WAS PURCHASED WITHIN AN IRA ACCOUNT WHICH HAD TO BE A SEPARATE CONTRACT. CURRAN FELT THAT BY DIVERSIFYING AMONG FUND MANAGERS AND FUNDS, THE CLIENT WOULD RECEIVE THE BENEFIT OF BETTER OVERALL PERFORMANCE. SINCE THERE WERE NO GUARANTEES EXTENDED TO THE CLIENT ON THESE CONTRACTS, AND SINCE THE FEATURES OF THE ANNUITIES WERE PROPERLY DISCLOSED, THE CLIENT'S REQUEST FOR REIMBURSEMENT WAS DENIED.
