FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.

- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:

- information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
- information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement
In June of 2013, a judgement was entered against Mr. Lykins from 460 Berkley Development Company LLC. Lykins was unaware of the recorded lien. The matter arose from a divorce whereby Mr. Lykins former wife was living at a residence in Winnetka Illinois. The former wife had multiple issues in the residence and prepared to exit the property. Mr. Lykins was named in a suit by 460 Berkeley for unpaid rents. This amount was in dispute. Immediately subsequent to the suit and finding 460 Berkeley was not to be located. The entity has been involuntarily dissolved on 4/11/2014 according to the State of Illinois business registration division. Therefore, it is unclear whom actually entered the judgement. No party has responded to this matter.
