- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

WE FOUND THAT THE CLIENT WAS NOT ADVISED OF THE SPOUSAL CONTINUATION OPTION FOR HER DECEASED HUSBAND'S ANNUITY CONTRACT AND THAT A NEW ANNUITY CONTRACT WAS OPENED FOR HER. HOWEVER, WE FOUND THAT, DUE TO THE GROWTH ON THE NEW ANNUITY AND A DEATH BENEFIT, THE NET AMOUNT THE CLIENT RECEIVED IN THE 1035 EXCHANGE TO THE NEW COMPANY, WAS GREATER THAN THE TRANSFER AMOUNT HAD THE CONTRACT BEEN CONTINUED AND THEN TRANSFERRED.
