- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

The firm examined all of the account documentation concerning the insurance policy and determined that there were no unauthorized withdrawals. Neither the firm nor the registered representative had control over or access to the customer's personal checking account. The firm informed the customer by letter of its findings and transmitted the supporting documentation to the customer. The firm did not receive a response from the customer and has closed its file.

RR Comments: I terminated my relationship with the customer in August 2016 which is prior to her written communication to the firm. Prior to the firm informing the customer that her communication had no merit, the customer had been harassing me through her hostile behavior-including leaving seventeen inappropriate, vulgar and irrational voicemails on my phone-to the extent that my firm's security department as well as local law enforcement had to intervene.
