- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations:	Client alleges that instructions to liquidate and transfer \$129,000 of a CFS brokerage account holding of Lord Abbett US Government Securities fund (LACXX) were not completed as intended to fund a Morningstar Managed Portfolios Moderate Growth account in March of 2015. The non-transaction resulted in a missed opportunity for gains calculated by CFS as approximately \$7,006. As an accommodation due to a potential misunderstanding, CFS has submitted a settlement offer to the client in the amount of \$8,000, to compensate the client for the missed investment opportunity as well as additional interest compensation. **Updated to confirm settlement and accommodation payment of \$8,000 to client completed by CFS on 1/10/2018 to resolve the issue.
