BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

ACCORDING TO OUR RECORDS, THE CLIENT PURCHASED A HARTFORD DIRECTOR VII ANNUITY IN MARCH, 2001. FRUIT HAS INDICATED HIS CONVERSATIONS WITH THE CLIENT REGARDING THE ANNUITY INCLUDED MARKET FLUCTUATION AND ASSOCIATED RISK. SINCE THE ANNUITY WAS PURCHASED, THE CLIENT HAS RECEIVED STATEMENTS FROM THE ANNUITY COMPANY AS WELL AS EDWARD JONES WHICH REFLECT THE SUB-ACCOUNTS SELECTED. FRUIT HAS INDICATED THE CLIENT DID CONTACT HIM EXPRESSING CONCERN REGARDING THE PERFORMANCE OF THE ANNUITY. HE HAS FURTHER INDICATED HE ATTEMPTED TO EXPLAIN THE DISADVANTAGES OF MAKING CHANGES TO PORTFOLIO ALLOCATIONS DURING DIFFICULT TIMES, BUT BELIEVES HE WAS NOT ALLOWED AN OPPORTUNITY TO OFFER ALTERNATIVES TO THE CLIENT. AS THE CLIENT HAS INDICATED, THE SUB-ACCOUNT ALLOCATIONS IN HER ANNUITY ARE "SIMILAR" TO (NOT THE SAME AS) THE SUB-ACCOUNT ALLOCATIONS IN HER HUSBAND'S ANNUITY. EXPLAINED WE UNDERSTAND THE CLIENT'S FRUSTRATION REGARDING THE DECLINE IN THE VALUE OF THE ANNUITY; HOWEVER, THE DECLINE IS ATTRIBUTED TO MARKET FLUCTUATION WHICH IS A RISK ASSOCIATED WITH INVESTING. IT IS OUR OPINION THE ANNUITY WAS PURCHASED WITH THE CLIENT'S AUTHORIZATION AND FRUIT DID INFORM HER OF THE RISKS OF MARKET FLUCTUATION. CLAIM DENIED.
