BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: ATTORNEY FOR THE TRUST INDICATES, AS A RESULT OF ADVICE RECEIVED FROM THE IR, HIS CLIENTS SURRENDERED ANNUITIES WHICH RESULTED IN A LARGE TAX BURDEN. ATTORNEY CLAIMS THERE WERE OTHER OPTIONS AVAILABLE TO HIS CLIENTS AND THE TRUST HAS SUFFERED SIGNIFICANT FINANCIAL LOSSES (INCLUDING LOSS OF INCOME) AS A RESULT OF THE LIQUIDATION OF THE ANNUITIES. ATTORNEY STATES HE HOPES TO HAVE THE \$95,093.54 TAX LIABILITY RESTORED TO THE TRUST AS WELL AS ANY INCOME THE FUNDS WOULD HAVE EARNED FROM THE TIME OF LIQUIDATION TO THE TIME OF RESTORATION.

ACCORDING TO THE IR, AT THE DIRECTION OF THE TRUSTEE, DISTRIBUTIONS WERE MADE FROM THE TRUST IN MAY 2005 AND AUGUST 2005. AT THE TIME OF CUSTOMER'S PASSING, THE TRUSTEE INDICATED TO THE IR THAT HE WANTED TO ENSURE THE TRUST/ESTATE WAS PROCESSED AS QUICKLY AS POSSIBLE. IT IS UNDERSTOOD THE TRUSTEE DID NOT WISH TO HAVE PAYMENTS SPREAD OUT AND WAS CONCERNED ABOUT POSSIBLE LIMITATIONS FOR FUTURE DISTRIBUTIONS IF ANNUITIZATION WAS ELECTED. AS TO THE POTENTIAL TAX CONSEQUENCES OF THIS DECISION, THE IR ADVISED THE TRUSTEE TO CONSULT WITH HIS TAX PREPARER REGARDING WHETHER OR NOT TO WITHHOLD TAXES FROM THE DISTRIBUTION. IT IS UNDERSTOOD THE IR ALSO PROVIDED THE TRUSTEE WITH A TAX PROFESSIONAL'S TELEPHONE NUMBER AND SUGGESTED THE TRUSTEE CONSULT WITH THE TAX PROFESSIONAL IN REGARD TO THE POTENTIAL TAX CONSEQUENCES. ACCORDING TO OUR RECORDS, THE TRUSTEE SUBSEQUENTLY COMPLETED THE PAPERWORK REQUIRED TO FACILITATE THE SURRENDER OF THE ANNUITIES. PURSUANT TO THE TRUSTEE'S INSTRUCTIONS, THE ANNUITIES WERE SURRENDERED, TAXES WERE WITHHELD AND THE PROCEEDS DEPOSITED IN THE EDWARD JONES ACCOUNT. AS TO THE ISSUE OF ANNUITIZATION, AS PREVIOUSLY INDICATED, THE TRUSTEE APPARENTLY WANTED TO ENSURE THE TRUST/ESTATE WAS PROCESSED AS QUICKLY AS POSSIBLE. REGARDLESS, THE LIQUIDATIONS WERE PROCESSED ACCORDING TO INSTRUCTIONS RECEIVED FROM THE TRUSTEE WHO WAS APPARENTLY AWARE OF THE POTENTIAL TAX CONSEQUENCES ASSOCIATED WITH THE DISTRIBUTIONS. THEREFORE, IN LIGHT OF THE INFORMATION PROVIDED, ANY REQUEST FOR A REIMBURSEMENT OF THE TAX LIABILITY INCURRED BY THE TRUST OR ANY OF ITS BENEFICIARIES IS RESPECTFULLY DENIED.
