WHILE EMPLOYED AT METLIFE THE EMPLOYER MAINTAINED AND COVERED LICENSE FEES. INADVERTENTLY, MY WISCONSIN INSURANCE HAD NOT BEEN RENEWED AND WHEN ATTEMPTING TO OBTAIN AN APPOINTMENT FOR HEALTH INSURANCE, THE DEFICIENCY WAS DISCOVERED.
