BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. THE LEHMAN BONDS HAVE NOT PAID AND WE HAVE LEARNED THAT THE TRANSFER AGENT FOR LEHMAN HAS NOT REDEEMED BONDS UNDER THE ESTATE FEATURE FOR ANY BONDS SUBMITTED AFTER JULY. UPON REVIEW OF THE INVESTMENTS THAT WERE HELD IN THE ACCOUNT, THEY DID NOT APPEAR TO BE OUTSIDE OF THE INVESTMENT OBJECTIVES LISTED ON THE ACCOUNT. WHILE WE CERTAINLY UNDERSTAND THE CLIENT'S DISAPPOINTMENT WITH THE LEHMAN BONDS, THE REQUEST FOR COMPENSATION WAS RESPECTFULLY DENIED.
