About BrokerCheck®



BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. OUR RECORDS INDICATE THE CONTRACTS WERE ISSUED IN 2001 AND 2003. AT THE TIME OF THE PURCHASES, IR INDICATED CLIENT INFORMED HIM THESE FUNDS WERE TO BE SET ASIDE FOR SON, AND CLIENT HAD NO INTENTION OF SPENDING THIS MONEY. IR STATED THE ANNUITY WAS SUGGESTED IN PART DUE TO THE DEATH BENEFITS, TAX DEFERRAL AND AS A MEANS TO AVOID PROBATE BY NAMING BENEFICIARY. SON, [FAMILY MEMBER], IS NAMED PRIMARY BENEFICIARY (100%) ON EACH OF CONTRACTS. CLIENT IS EXPERIENCED WITH INVESTMENTS SUSCEPTIBLE TO MARKET FLUCTUATION AND IR HAS WORKED TO HELP CLIENT MOVE POSITIONS FROM ANOTHER FIRM. AT TIME OF PURCHASE, IR STATED HE REVIEWED ALL ASPECTS OF THE ANNUITY TO INCLUDE THE SURRENDER PERIOD; HOWEVER, HE STATED THIS WAS NOT A CONCERN BECAUSE THE CLIENT'S INTENTION WAS TO PASS THESE FUNDS ON TO HER SON. CLIENT WAS PROVIDED WITH CONTRACTS ON EACH ANNUITY AS WITNESSED BY THE SIGNED DELIVERY RECEIPTS OF WHICH COPIES WERE PROVIDED TO CLIENT, WHICH SET OUT ALL DETAILS OF ANNUITY POLICIES. BASED ON OUR REVIEW, IT DOES APPEAR CLIENT WAS PROVIDED WITH ALL DETAILS OF THE ANNUITY CONTRACTS AND AUTHORIZED THE PURCHASES IN 2001 AND 2003. FURTHER, IT APPEARS THE RECOMMENDATION OF THE ANNUITIES WAS BASED ON IR'S UNDERSTANDING OF OBJECTIVES FOR THESE FUNDS AT THE TIME OF PURCHASE. BOTH CONTRACTS DO APPEAR TO REFLECT GAINS AS OF THE DATE OF LETTER. CLAIM DENIED.
