#### What is included in a BrokerCheck report?

  qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck
  reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
  same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and

Woodmen Financial Services, Inc.

Allegations:

The client purchased a Jackson National Variable Annuity on August 19, 2021. He states he was not explained all of the product features and that the transaction was a replacement in which he wasn't made aware of the advantages or disadvantages. This variable annuity was funded with death proceeds from another product on the life of another person, and as the client did not own the previous product, it was not a replacement. The paperwork was completed accurately showing it was not a replacement. The firm believes the features of the variable annuity were explained to the client. In reviewing this allegation, Woodmen Financial Services inquired into the circumstances of the purchase from Registered Representative Irving Hodges. Mr. Hodges explained that the purchase of the variable annuity was properly explained over several meetings and any questions the client had were answered.
