BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

EDWARDS IN JULY 2000; CLIENT STATED ECHELMEIER KNEW SHE WANTED TO TAKE WITHDRAWALS FROM HER IRA STARTING AT 59 1/2 AND CONTINUED TO ASK HER IF SHE WAS INVESTED CORRECTLY IN HER ACCOUNTS. THE CLIENT STATES HER ACCOUNT HAS ONLY GONE DOWN IN VALUE AND CLAIMS SHE BELIEVES SHE WAS "MISINVESTED" AND TAKEN ADVANTAGE OF AND DOES NOT UNDERSTAND WHY SHE WAS NOT PLACED IN LONG-TERM CDS AND JUST GOOD MUTUAL FUNDS TO MEET HER NEEDS. CLIENTS UNREALIZED LOSSES EXCEED \$5,000.

ACCOUNTS WERE TRANSFERRED IN FROM ANOTHER FIRM. ECHELMEIER (IR) STATED SHE MET WITH CLIENT ON SEVERAL OCCASIONS ATTEMPTING TO EDUCATE HER AS TO THE FEES ASSOCIATED WITH THE MUTUAL FUNDS, MARKET VOLATILITY AND THE NEED TO HOLD THESE INVESTMENTS LONG-TERM. IR STATED SHE DID DISCUSS OPTIONS AVAILABLE TO THE CLIENT AND AGREED TO MEET WITH THE CLIENT ON A MONTHLY BASIS TO DISCUSS CONCERNS AND ADDRESS ANY QUESTIONS THE CLIENT MIGHT HAVE. THE IR STATED THE CLIENT WAS MOST UNCOMFORTABLE WITH THE PUTNAM FUNDS AND, ULTIMATELY, THE IR SUGGESTED MOVING SOME OF THE PUTNAM FUNDS TO AMERICAN FUNDS. BREAKPOINTS WERE REACHED AND ALL FEES ASSOCIATED WITH THE CHANGE WERE DISCUSSED WITH THE CLIENT. THE ANNUITY PURCHASED FOR THE CLIENT WAS ISSUED ON 7/3/00 AFTER INITIAL CONVERSATIONS WITH THE CLIENT IN WHICH SHE INDICATED HER OBJECTIVE WAS TO OBTAIN GREATER GROWTH ON HER INVESTMENTS. THE IR STATED THE CLIENT INFORMED HER THIS MONEY WAS COMING FROM HER MOTHER'S ESTATE AND SHE DID NOT NEED INCOME FROM IT AND DID NOT WANT TO PAY ADDITIONAL TAXES. THE ANNUITY WAS DISCUSSED AND ALL FEATURES DISCLOSE. A DCA FOR 6 MONTHS WAS ESTABLISHED TO MOVE THE MONEY SLOWLY INTO 3 SUB-ACCOUNTS, STOCK FUND, ADVISORS AND CAPITAL APPRECIATION. THE FUNDS WERE CHOSEN BASED ON THE GROWTH OBJECTIVE OF THE CLIENT, PAST PERFORMANCE AND FUND MANAGEMENT. THE CLIENT WOULD HAVE RECEIVED A CONTRACT AND FUND PROSPECTUSES ON THIS INVESTMENT. THE CLIENT WOULD HAVE ALSO RECEIVED CUSTOMER STATEMENTS INDICATING THE ANNUITY SUB-ACCOUNTS AS WELL AS OUR (EDWARD JONES) ASSET CATEGORIES. CLAIM DENIED.
