BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. THE INVESTMENTS THAT WERE PURCHASED IN THE CLIENT'S ACCOUNT WERE APPROPRIATE AND MET THE CLIENT'S INVESTMENT OBJECTIVES. THE FA DID SUGGEST THAT THE CLIENT MAY WANT TO CONSIDER A REVERSE MORTGAGE AS A SOURCE OF REVENUE, RATHER THAN SELLING HER HOME, BUT NEITHER THE FA NOR EDWARD JONES MADE ANY MONEY FROM THIS TRANSACTION. FOR SEVERAL YEARS, THE CLIENT HAD REQUESTED THAT THE FA BE THE EXECUTOR OF HER ESTATE. HE HAD ALWAYS DECLINED HER OFFER STATING THAT THE FIRMS THAT HE WORKED FOR WOULD NOT ALLOW HIM TO OFFER FINANCIAL ADVICE AND BE HER EXECUTOR. THE ADVICE FROM EDWARD JONES WAS THE SAME, BUT OUR FIELD SUPERVISION DEPARTMENT ADVISED THAT THE ONLY WAY THAT HE COULD SERVE IN THIS CAPACITY WAS TO MOVE THE ACCOUNT TO ANOTHER BRANCH OFFICE OR OUT OF OUR FIRM ALTOGETHER. WHEN THE FA BECAME THE TRUSTEE/EXECUTOR FOR THE CLIENT'S ACCOUNT, THE INVESTMENTS HELD IN HER ACCOUNT WERE TRANSFERRED BACK TO THE MUTUAL FUND COMPANY AND THE FA WAS REMOVED AS THE AGENT OF RECORD. SINCE HE WAS NO LONGER ASSOCIATED WITH THIS ACCOUNT OR PROVIDING FINANCIAL ADVICE ON THE ACCOUNT, WE FELT THAT HE COULD SERVE AS THE EXECUTOR OF THE CLIENT'S ESTATE.
