• What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.
- How current is this information?
- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- Are there other resources I can use to check the background of investment professionals?

 - An "adjudicated" matter includes a disposition by (1) a court of law in a criminal or civil matter, or (2) an administrative panel in an action brought by a regulator that is contested by the party charged with some alleged wrongdoing.
 - A "settled" matter generally involves an agreement by the parties to resolve the matter. Please note that brokers and brokerage firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually involves no payment to the customer and no finding of wrongdoing on the part of the individual broker. Such matters generally involve customer disputes.

MY SUPERVISOR GAVE ME ALL NECESSARY PAPERWORK TO OPEN AN OFF-SITE CHECKING ACCT WITH AN INMATE. INMATE HAD RCVD A DEATH BENEFIT FROM THE DEATH OF HER MOTHER. SHE WAS NOT ALLOWED TO KEEP THE 38K IN HER INMATE CANTEEN. I OPENED THE NEW ACCT, GOT ALL APPROPRIATE SIGNATURES, SHE WAS IDENTIFIED BY THE BCCI LEGAL COUNSEL ATTY, THOMAS HANNON, AND THE OFFICER ON DUTY. INMATES DO NOT CARRY ID'S. MY MGR DISCUSSED WITH ME THAT I DID NOT GET HER DRIVER LICENSE NUMBER. I EXPLAINED THE LIMITATIONS I WAS UNDER AND NOTHING MORE WAS SAID ABOUT THIS UNTIL DEC 2, 2014, WHEN HE BROUGHT IT UP, AND TERMINATED ME.
