- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. - **Are there other resources I can use to check the background of investment professionals?**

Broker Statement

The pro se customer was never the RR's client. He did not hold any securities at the firm or with the RR. The pro se customer was never the RR's client and never purchased any securities through the RR. The allegations are demonstrably false and wholly without merit and should the matter progress to a formal dispute the firm and RR will defend the matter vigorously and fully expect that they would prevail at any hearing on the merits. The pro se customer, a professional investor, had a pre-existing large position in the issuer as well as a pre-existing relationship with the issuer and its CEO. A review of public filings reflects that the pro se customer regularly bought the securities of the issuer at another broker-dealer and not through the RR or his firm. Although there is no arbitration or litigation threatened or pending against the RR or the firm, should the pro se customer elect to commence an action such action would be patently frivolous, the RR and firm would defend it vigorously and fully expect that they would prevail at any hearing on the merits.
