BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. TRUSTEE STATES IR RECOMMENDED ANNUITIZATION AND CLIENT BELIEVED THE DEATH BENEFIT REMAINING WOULD BE RETURNED TO THE ESTATE. TRUSTEE ALLEGES THAT HAD THE IR INFORMED HIM THAT ANNUITIZING THE CONTRACT WOULD RESULT IN THE VALUE CONVERTING TO A "PRESENT VALUE," IN EFFECT REDUCING THE DEATH BENEFIT, TRUSTEE WOULD HAVE NEVER AGREED TO THIS OPTION. TRUSTEE STATES THE CLIENT HAS NOW PASSED AWAY AND THE ESTATE/BENEFICIARIES WILL RECEIVE APPROXIMATELY \$11,698.22 LESS THAN THEY WOULD HAVE HAD IR PROPERLY ADVISED HIM.

ACCORDING TO IR, CLIENT MOVED TO AN ASSISTED LIVING FACILITY IN NOVEMBER 2003. IR INDICATED THAT AT THAT TIME, CLIENT'S ACCOUNT WAS REVIEWED WITH A PURPOSE OF DETERMINING THE ALTERNATIVE AVAILABLE TO CLIENT FOR PAYING THE ADDITIONAL EXPENSES ASSOCIATED WITH CLIENT'S RELOCATION. IR FURTHER INDICATED HE MET WITH THE TRUSTEE AS WELL AS THE CLIENT ON SEVERAL OCCASIONS AND EVENTUALLY SUGGESTED ANNUITIZING THE HARTFORD ANNUITY. IR BELIEVED THIS WOULD PROVIDE THE CLIENT WITH ADDITIONAL CASH FLOW TO MEET EXPENSES AND HAD THE POTENTIAL TO PROVIDE TAX BENEFITS. THE CLIENT RECEIVED THE FIRST PAYMENT AND, UNFORTUNATELY, PASSED AWAY IN JANUARY 2004. THE TRUSTEE SUBSEQUENTLY CONTACTED IR TO DETERMINE THE OPTIONS AVAILABLE FOR DISTRIBUTING THE ANNUITY TO THE BENEFICIARIES. IR INDICATED HE EXPLAINED THE PAYMENTS COULD BE CONTINUED WITH DEPOSITS BEING MADE TO THE TRUST ACCOUNT AND FUNDS BEING DISTRIBUTED TO THE BENEFICIARIES EACH MONTH, OR THE CONTRACT COULD BE SURRENDERED AS A LUMP SUM DISTRIBUTION. IT IS UNDERSTOOD THE TRUSTEE CHOSE TO TAKE A LUMP SUM DISTRIBUTION AS TRUSTEE BELIEVED THE BENEFICIARIES WOULD WANT TO HAVE THIS SITUATION RESOLVED AS QUICKLY AS POSSIBLE. WHEN THE CONTRACT WAS ANNUITIZED THE CLIENT RECEIVED CORRESPONDENCE FROM HARTFORD INDICATING PAYMENTS WOULD BE MADE UNTIL NOVEMBER 13, 2013. HOWEVER, IF THE PAYMENTS WERE DISCONTINUED AND A LUMP SUM DISTRIBUTION TAKEN, THE PRESENT VALUE OF THE REMAINING GUARANTEED PAYMENTS WOULD BE MADE. BASED ON OUR REVIEW, THE ANNUITY WAS SURRENDERED AT THE REQUEST OF THE TRUSTEE. THE DISTRIBUTION WAS CALCULATED BY HARTFORD LIFE AND THE PAYMENT MADE ACCORDINGLY. CLAIM DENIED.
