BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. CLIENT'S ACCOUNT WAS ESTABLISHED IN SEPTEMBER 2000 WITH ASSETS CLIENT RECEIVED FROM ANOTHER ACCOUNT AS A NAMED BENEFICIARY. DURING INITIAL DISCUSSIONS, CLIENT INDICATED HER OBJECTIVES WERE LONG-TERM GROWTH AND GROWTH AND INCOME; THEREFORE, IR RECOMMENDED LIQUIDATING BONDS AND REPOSITIONING INTO MUTUAL FUNDS. AN ACKNOWLEDGMENT LETTER FOR REPOSITIONING OF ASSETS WAS EXECUTED ON OCTOBER 17, 2000. OUR RECORDS REFLECT THE MAJORITY OF ASSETS WERE IN GROWTH AND GROWTH AND INCOME INVESTMENTS. AN ASSET CATEGORY OF ONE MUTUAL FUND, PUTNAM VISTA, DID CHANGE FROM GROWTH TO AGGRESSIVE GROWTH IN DECEMBER 2001 AND THESE FUNDS WERE LATER EXCHANGED TO PUTNAM MID CAP VALUE IN MAY 2002. CLIENT WOULD HAVE RECEIVED TRADE CONFIRMATIONS AT TIME OF PURCHASE(S) AS WELL AS FUND PROSPECTUSES. CLIENT WOULD HAVE RECEIVED CUSTOMER ACCOUNT STATEMENTS WHICH REFLECT ALL ACTIVITY IN THE ACCOUNT, SET OUT INVESTMENTS HELD IN THE ACCOUNT, THE ASSET CATEGORIES, AS WELL AS CURRENT VALUES. IN SEPTEMBER 2002, IR STATED HE RECEIVED A CALL FROM CLIENT REQUESTING CHANGES WITH ALL INVESTMENTS. IR STATED HE RECOMMENDED NOT MAKING CHANGES AT THAT TIME, HOWEVER, IR DID EXCHANGE FUNDS AS THE CLIENT REQUESTED. AFTER SAID CHANGES, CLIENT'S PORTFOLIO WAS COMPRISED OF PRIMARILY CASH/MONEY MARKET AND INCOME INVESTMENTS. BASED ON OUR REVIEW, IT DOES APPEAR CLIENT'S ACCOUNT WAS INVESTED WITHIN THE SCOPE OF CLIENT'S INVESTMENT OBJECTIVES AND PURSUANT TO CLIENT'S DISCUSSIONS WITH IR. WHILE WE UNDERSTAND CLIENT'S DISAPPOINTMENT WITH THE PERFORMANCE OF MUTUAL FUNDS DURING THE PERIOD IN QUESTION, IT DOES APPEAR TO BE THE RESULT OF MARKET FLUCTUATION, WHICH IS A RISK ASSOCIATED WITH INVESTING. CLAIM DENIED.
