BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

CLIENTS STATE THEY WERE INFORMED THERE WERE 3 INVESTMENT OPTIONS TO CHOOSE FROM AND BEING CONSERVATIVE THEY CHOSE THE MOST CONSERVATIVE OPTION MADE AVAILABLE. CLIENTS CLAIM THEY LATER LEARNED THAT EACH STATE OFFERS A DIFFERENT SET OF INVESTMENT OPTION AND HAD THEY BEEN INFORMED CORRECTLY BY MUENZ THEY WOULD HAVE BEEN ABLE TO INVEST IN A FIXED INCOME INVESTMENT. WHEN THEY QUESTIONED MUENZ, THEY CLAIM HE WAS SURPRISED TO LEARN THESE OTHER STATE PLANS EXISTED AS WELL AS THE POTENTIAL STATE INCOME TAX DEDUCTION FOR 2002. CLIENTS CLAIM THEY HAVE CONTACTED PUTNAM FUNDS AND AFTER DISCUSSIONS WITH THEM ARE REQUESTING A LETTER OF INDEMNITY BE PROVIDED AND THE LOSSES REIMBURSED. FILING REQUIRED; LOSSES EXCEED \$5,000

MUENZ (IR) STATED HE DISCUSSED THE PUTNAM 529 PLAN IN AN INITIAL 2 HOUR MEETING WITH THE CLIENT AT WHICH TIME HE PROVIDED A PLAN PACKET AND PROSPECTUSES ON THE FUND OPTIONS FOR THE CLIENT TO TAKE HOME AND REVIEW. AT THE SECOND MEETING THE IR STATED HE WENT AGAIN INTO FULL DETAIL OF THE 529 PLAN. THE IR STATED HE REVIEWED MARKET RISKS, COMMISSIONS, LIQUIDITY, ETC. THE INVESTMENTS WERE MADE INTO THE BALANCED AND AGE-WEIGHTED OPTIONS AS REQUESTED BY THE CLIENT AS THEY HAD REVIEWED THE PROVIDED INFORMATION AND WISHED TO STAY CONSERVATIVE THE IR INDICATED HE WAS NEVER INFORMED THE CLIENT WANTED A FIXED INCOME OPTION OR THAT THE CLIENTS BELIEVED THE PUTNAM INVESTMENTS WERE TOO AGGRESSIVE UNTIL AFTER THE INVESTMENTS HAD BEEN MADE AND THE CLIENT HAD APPARENTLY LOOKED AT ANOTHER 529 PLAN. THE IR STATED HE NEVER INSINUATED THE PUTNAM 529 PLAN WAS THE ONLY 529 PLAN AVAILABLE; ONLY, THAT THIS IS THE ONLY PLAN EDWARD JONES CURRENTLY OFFERS. THE IR STATED HE OBTAINED INFORMATION AT THE CLIENT'S REQUEST REGARDING THE TERMINATION OF THE PLANS AND LIQUIDATION OF THE ASSETS AND THIS INFORMATION AS WELL AS THE NECESSARY FORMS WERE PROVIDED TO THE CLIENT AS WELL AS THE CURRENT VALUE OF



THE INVESTMENTS. THE
FORMS WERE NEVER RETURNED AND THE ASSETS WERE LIQUIDATED
DIRECTLY THROUGH PUTNAM
FUNDS PURSUANT TO THE WRITTEN REQUESTS OF THE CLIENTS SENT
DIRECTLY TO PUTNAM. CLAIM
