#### What is included in a BrokerCheck report?

- BrokerCheck reports for individual brokers include information such as employment history, professional
  qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck
  reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the
  same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.
- Where did this information come from?
- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
  - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
  - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.
- How current is this information?

parted ways with UBS . UBS filed an arbitration proceeding with FINRA to recover the loan they made to me when I was hired that is traditionally forgiven over time . UBS prevailed in the arbitration before FINRA and refused to work with me to structure a reasonable payout I could afford . In order to obtain a fresh start, I filed ch 7 in order to discharge the obligation to UBS . My dispute with UBS had nothing to do with my honesty or integrity or with client issues . The bankruptcy code only permits honest people to obtain a discharge of their debts. My Chapter 7

bankruptcy has been successfully discharged at this time.
