- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

This claim is without merit, and, as such, the claim was denied after a thorough investigation. We were present for a face-to-face meeting with the clients, where we detailed the recommendations to sell the mutual funds that, while profitable from original investment, carried tax losses due to capital gain reinvestment. Clients acknowledged understanding the rationale of the recommendation and then provided verbal authorization to sell the funds. The account was fee-based, so we were not compensated for selling the funds. Thus, we had no economic incentive or financial benefit from executing the agreed-upon transactions or the recommended reinvestment. The next day, confirmation of the trades was sent to the client's desired email address, and I contacted the client as a follow-up by both telephone and email during the week the transactions occurred. Also, the client logged in online to view their accounts on several subsequent dates. After denying this claim, local Raymond James management indicated to the client that they had the opportunity to buy back sold shares at an improved, lower price. The client did not repurchase at the lower price, however, had they, the client would have realized a net gain on the repurchased shares.
