FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: THE BENEFICIARY STATES THE IR DID NOT HANDLE THE ACCOUNT PROPERLY DURING THE STOCK MARKET DECLINE THAT BEGAN IN EARLY 2000. HE CLAIMS THE IR IS LISTED AS ONE OF THE BENEFICIARIES ON THE ESTATE. HE WANTS JONES TO DIRECT THE PROCEEDS TO THE 16 BENEFICIARIES AND NOT JONES OR THE IR; THE IR TO FORGO COMMISSIONS FROM THE ESTATE LIQUIDATION AS HE IS ALLEGEDLY ONE OF THE BENEFICIARIES OF THE ESTATE AND THIS CREATES A CONFLICT OF INTEREST; MAKE THE BENEFICIARIES WHOLE AS OF JULY 2001. HE ALSO WANTS THE ADDRESSES OF ALL THE BENEFICIARIES, THE MONTHLY VALUE OF THE ESTATE FROM JULY 2001-NOVEMBER 2002, AND RECORDS OF TRANSACTIONS FOR THE ESTATE. HE CLAIMS THE LOSSES COULD BE GREATER THAN \$10,000. LOSSES CLAIMED EXCEED \$5,000.

FURTHERMORE, IT WOULD APPEAR THERE HAVE BEEN NO OBJECTIONS MADE TO THIS BENEFICIARY DISTRIBUTION TO THE IR BY EITHER THE EXECUTOR, THE ESTATE ATTORNEY, OR THE OTHER BENEFICIARIES. FINALLY, AS TO CLAIMANT'S CONCERNS REGARDING THE ALLEGED MISMANAGEMENT OF THIS ACCOUNT BY THE IR, THERE HAVE BEEN NO CONCERNS VOICED BY THE AUTHORIZED PARTIES, THE EXECUTOR AND/OR THE ESTATE ATTORNEY, AS TO IR'S HANDLING OF THIS ACCOUNT.
