- **Where did this information come from?**

**Allegations:** Without admitting or denying the findings, Nordaune consented to the sanctions and to the entry of findings that he signed a customer's name on a membership application that his member firm required for the transfer of ownership of a variable annuity without the customer's knowledge and in violation of his firm's policies, thus falsifying the document. The findings stated that the customer received a copy of the membership application and complained to Nordaune, who suggested that she had electronically signed the document but forgotten about it. The customer then complained to the firm, who terminated Nordaune's association and transferred the variable annuity in accordance with the customer's wishes.
