FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Allegations: CLIENT STATES IR DID NOT INFORM HIM OF THE CONSEQUENCES OF A DECREASE IN STKS HELD IN HIS MARGIN ACCT AND HOW "AT RISK" HIS PORTFOLIO WAS AS A REUSLT OF HIS MARGIN ACTIVITY. CLIENT STATES BETWEEN 1/2000 AND 4/2000 HIS PORTFOLIO VALUE HAD DECLINED FROM \$300,000 TO \$200,000. CLIENT STATES DURING THIS TIME PERIOD HE REQUESTED TO LIQUIDATED HIS STOCK, HOWEVER, IR HAD RECOMMENED HE HOLD HIS POSITIONS. CLIENT STATES THE ACCOUNT VALUE DROPPED TO \$100,000, THE ORIGINAL AMOUNT INVESTED, BY 10/2000.
