BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

ALL CLAIMANTS WERE FURNISHED ALTERNATIVE INVESTMENT OPTIONS AND PROPER INFORMATION TO MAKE INFORMED DECISIONS CONCERNING THEIR INVESTMENTS. EACH CLAIMANT FIRMLY REQUESTED THE MAXIMUM ALLOWABLE 72-T ANNUAL DISTRIBUTION, WHICH AT THAT TIME WAS 10%. SUBSEQUENT MARKET ACTIVITY FROM 3/2000 TO 10/2002, COMBINED WITH THIS EXCESSIVE DISTRIBUTION RATE, WAS VERY DETRIMENTAL TO THEIR INVESTMENT ACCOUNTS.

THE CUSTOMER OPENED THE VARIABLE ANNUITY 10/05/1999 AND THE OTHER CONTRACT WAS OPENED 7/28/1999. MR. HUGH WAS NOTIFIED BY THE CUSTOMER ON 2/14/2001 WHERE THE CUSTOMER EXPRESSED HIS DISPLEASURE KNOWING THAT HE COULD NOT TAKE A COMPLETE DISTRIBUTION FROM THE ANNUITY WITHOUT INCURRING SURRENDER CHARGES. MR. HINSON DENIES EVER TELLING THE CUSTOMER THAT HE WOULD BE ABLE TO WITHDRAW THE MONEY AT ANY TIME WITHOUT SURRENDER CHARGES BUT IN FACT TOLD HIM THAT HE WOULD HAVE THE ABILITY TO WITHDRAW UP TO 15% OF THE ORIGINAL AMOUNT INVESTED EACH YEAR DURING THE SURRENDER CHARGE PERIOD WITHOUT INCURRING ANY SURRENDER CHARGES. DAMAGES NOT SPECIFIED.
