BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

Broker Statement

IR ADVISED THAT HE MET WITH THE CLIENTS IN 1998 AND OPENED ACCOUNTS FOR THEM AT THAT TIME. THE IRA ACCOUNT WAS FUNDED WITH AN IRA ROLLOVER AND AN ANNUITY WAS ALSO TRANSFERRED IN AND LINKED TO THIS ACCOUNT. THE CLIENTS ALSO OPENED A JOINT ACCOUNT AND 1035 EXCHANGED ANNUITIES FROM FORTIS. THE IR ADVISED THAT HE CALLED FORTIS TO DETERMINE IF THERE WERE ANY SURRENDER CHARGES ASSOCIATED WITH THIS EXCHANGE, AND THE CLIENTS WERE ADVISED OF THE FEES. IR ALSO HAD THE CLIENTS SIGN ACKNOWLEDGEMENT LETTERS SHOWING THAT THEY UNDERSTOOD THE FEES ASSOCIATED WITH THIS EXCHANGE. DURING THE PAST SIX YEARS, IR STATED HE MET NUMEROUS TIMES WITH THE CLIENTS TO DISCUSS THEIR PORTFOLIOS AND REVIEW MARKET FLUCTUATION. IR ALWAYS ADVISED THE CLIENTS TO DIVERSIFY AMONG OTHER MUTUAL FUNDS, AND FINALLY, IN 2000, THE CLIENTS AGREED TO EXCHANGE AMONG SOME OTHER FUNDS WITHIN THE FUND'S FAMILY. THE CLIENTS WERE SENT CUSTOMER STATEMENTS AND VERIFICATION LETTERS DURING THE PAST SIX YEARS DISCLOSING THE VALUE OF THEIR ACCOUNTS, AND HOW THE FUNDS WERE INVESTED. THE IR ADVISED THAT THE CLIENTS' INSTRUCTIONS WERE FOLLOWED ON THESE ACCOUNTS. THE CLAIM FOR



REIMBURSEMENT FROM THE CLIENT'S ATTORNEY WAS
