- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

FIRST, IN THE MATTER OF THE SELL RECOMMENDATION PLACED ON THE LU STOCK ON 8/2/02, THE IR ADVISED ME THAT HE SENT A LETTER TO ALL OF HIS CLIENTS WHO HELD LU STOCK. HOWEVER, AT THE TIME THE LETTER WAS MAILED, HE WAS NOT AWARE THAT THE CLIENT HAD REQUESTED OF HIS PRIOR BOA TO BE PLACED ON THE "NO MAIL" LIST. THEREFORE, REGRETTABLY, A COPY OF THAT NOTICE WAS NOT SENT. AS TO THE ISSUE OF THE CLS STOCK, THE CHANGE IN THE EDWARD JONES RESEACH OPINION FROM A "BUY" TO A "HOLD" ON 9/18/02 WAS NOT AN EVENT THAT NECESSITATED A NOTIFICATION; HOWEVER, A CHANGE IN THE RATING WOULD BE NOTED ON THE CLIENT STATEMENT. I EXPLAINED TO THE CLIENT WHAT A "HOLD" OPINION MEANS. A PRIMARY ISSUE WITH YOUR ACCOUNT APPEARS TO BE THE METHOD OF COMMUNICATION BETWEEN THE IR AND THE CLIENT. IT MAY BE WISE FOR THE CLIENT AND THE IR TO REVIEW WHAT PROCEDURES WOULD BE BEST TO EXPEDITE COMMUNICATION AND IMPROVE THE EFFICIENCY WITH WHICH HE IS ABLE TO ASSIST THE CLIENT MORE EFFECTIVELY.
