BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- **What if I want to check the background of an investment adviser firm or investment adviser representative?**

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Allegations: ATTORNEY FOR CLIENTS STATES THAT IN AUGUST 2002, CLIENTS EXPRESSED THEIR DESIRE TO INVEST IN BOND MARKET AND TO AVOID STOCKS. CLIENTS CLAIM THAT IR CONVINCED THEM TO INVEST APPROXIMATELY \$20,000 IN LORD ABBETT AFFILIATED FUND. CLIENTS FURTHER STATE THAT IR TOLD THEM THAT ONLY 13% OF THE FUND WAS INVESTED IN STOCKS, BUT CLIENTS CLAIM ACTUAL AMOUNT WAS 97.1% AND BOND HOLDINGS WERE 1%. CLIENTS CLAIM THAT THEY SOLD THE FUND FOR A LOSS OF \$3,437.12 AND THAT THEY WOULD HAVE ENJOYED PROFITS OF \$3,292.68 IF FUNDS WOULD HAVE BEEN INVESTED ACCORDING TO THEIR DESIRES. TOTAL LOSSED CLAIMED EQUAL \$6,729.80.

Broker Statement

IR STATED THAT CLIENTS INDICATED THEY WANTED TO PLACE ALL \$60,000 IN FRANKLIN HIGH YIELD FUND. IR DISCUSSED THAT PLACING ALL AVAILABLE FUNDS INTO ONE INVESTMENT WAS NOT RECOMMENDED AND CLIENTS MAY WANT TO CONSIDER FURTHER DIVERSIFICATION. IR RECOMMENDED NOT SUCH A LARGE PORTION OF FUNDS BE PLACED INTO AGGRESSIVE BOND FUNDS AND AFTER MUCH DISCUSSION IT WAS DECIDED THAT THE \$60,000 WOULD BE SPLIT UP BETWEEN AFFILIATED, BOND DEBENTURE FUND AND FEDERAL HOME LOAN MTG. CORPORATION. IR STATED THAT THE FUND WAS NOT REPRESENTED AS BEING PRIMARLY INVESTED IN BONDS AND THAT THE PROSPECTUS WAS DELIEVERED, WHICH DETAILED THE MAKE-UP OF THE FUND. IR STATED THE INVESTMENT WAS ALSO DISCUSSED AGAIN AFTER THE PURCHASE AND AFTER THE PROSPECTUS WAS RECEIVED, AND CLIENTS DID NOT EXPRESS DISSATISFACTION WITH THE MAKE-UP OF THE FUNDS AND CHOSE TO KEEP THE INVESTMENT. CLAIM DENIED.
