- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

 - A "settled" matter generally involves an agreement by the parties to resolve the matter. Please note that brokers and brokerage firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually involves no payment to the customer and no finding of wrongdoing on the part of the individual broker. Such matters generally involve customer disputes.

On 1/23/2025 Quattro filed Form U-5 alleging that Mr. Conlon was "permitted to resign" and that he resigned while the firm was conducting an internal compliance review relating to OTC securities trading, including review of electronic order routing practices, customer, onboarding, and related supervisory controls.

Broker Statement

After Mr. Conlon voluntarily resigned, Quattro made false and/or misleading statements on his U5 stating that he was "permitted to resign" on 1/12/26 when, in fact, Mr. Conlon had voluntarily resigned. Without any specificity, Quattro stated that Mr. Conlon was under investigation at the time he was "permitted to resign," To date Mr. Conlon has never been told the basis of the purported investigation, nor has he been contacted or provided any information regarding the so-called investigation. Mr. Conlon believes that the filing of this defamatory Form U-5 is retaliatory, placing Mr. Conlon before the public in a false light.
