BrokerCheck offers information on all current, and many former, registered securities brokers, and all current and former registered securities firms. FINRA strongly encourages investors to use BrokerCheck to check the background of securities brokers and brokerage firms before deciding to conduct, or continue to conduct, business with them.

- **What is included in a BrokerCheck report?**

- BrokerCheck reports for individual brokers include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards. BrokerCheck reports for brokerage firms include information on a firm's profile, history, and operations, as well as many of the same disclosure events mentioned above.
- Please note that the information contained in a BrokerCheck report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the broker or brokerage firm, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

- **Where did this information come from?**

- The information contained in BrokerCheck comes from FINRA's Central Registration Depository, or CRD® and is a combination of:
 - o information FINRA and/or the Securities and Exchange Commission (SEC) require brokers and brokerage firms to submit as part of the registration and licensing process, and
 - o information that regulators report regarding disciplinary actions or allegations against firms or brokers.

- **How current is this information?**

- Generally, active brokerage firms and brokers are required to update their professional and disciplinary information in CRD within 30 days. Under most circumstances, information reported by brokerage firms, brokers and regulators is available in BrokerCheck the next business day.

- To check the background of an investment adviser firm or representative, you can search for the firm or individual in BrokerCheck. Allegations: THE CLIENT ALLEGED THAT THE IR MOVED FUNDS FROM HER ANNUITY INTO OTHER INVESTMENTS WITHIN HER EDWARD JONES' ACCOUNT, BUT DID NOT DISCLOSE THE TAX IMPLICATIONS OF THIS TRANSFER. THE CLIENT CONTINUALLY STRESSED THAT SHE WANTED TO MINIMIZE TAXES, AND WAS UNDER THE IMPRESSION THAT WHEN THIS TRANSACTION TOOK PLACE, SHE WOULD NOT INCUR ADDITIONAL TAXES. THE CLIENT HAS NOW BEEN ADVISED BY HER CPA THAT SHE OWES \$ 10,000.00 IN TAXES. THE CPA ADVISED THAT THE ANNUITY WAS 1035 EXCHANGED FROM A.G. EDWARDS, BUT THE IR DID NOT TAKE INTO CONSIDERATION THE ORIGINAL COST BASIS OF THE ACCOUNT.

THE IR INDICATED THAT HE MET WITH CLIENT AND HER SON SEVERAL TIMES TO REVIEW HER PORTFOLIO. CLIENT DISCUSSED THE ANNUITY HELD AT ANOTHER BROKER-DEALER AND ADVISED IR THAT THE VALUE DECLINED FROM \$70,000 TO \$60,000 DURING THE PAST FEW YEARS. NEITHER THE CLIENT NOR HER SON DISCLOSED TO IR THAT THIS ANNUITY WAS ORIGINALLY PURCHASED IN 1990 AT A SIGNIFICANTLY LOWER PRICE. CLIENT PROVIDED THE IR WITH A COPY OF HER CURRENT STATEMENT FROM THE BROKER-DEALER, WHICH SHOWED THE LOSS OF VALUE. IR CHECKED WITH INSURANCE MARKETING AND THEY CONFIRMED THAT THERE WOULD BE NO TAX IMPLICATION IF THE ANNUITY WAS SOLD AT A PRICE LOWER THAN THE ORIGINAL PURCHASE AMOUNT. SINCE THE CLIENT AND HER SON NEVER DISCLOSED THE EARLIER PURCHASE DATE, IT WAS DETERMINED THAT THERE WAS NO WAY THAT IR COULD POSSIBLY HAVE KNOWN THAT THE CLIENT WOULD INCUR THESE TAXES. THE CLIENT'S CLAIM WAS DENIED.
